TO ALL WHOM THESE PRESENTS SHALL COME – GREETINGS:

WHEREAS, Mr. Reginald Cornelius Latson, Jr., was granted a Conditional Pardon on January 20, 2015, for his convictions of May 31, 2011, and January 8, 2015, in Stafford County and conviction of March 7, 2014, in Frederick County, and the probation revocations associated with each of those offenses; and

WHEREAS, the conditions of the January 20, 2015, Pardon were to be fulfilled after a period of ten years; and

WHEREAS, Mr. Latson had fulfilled the conditions of the January 20, 2015, Pardon for over six years with full cooperation; and

WHEREAS, because conditions of the January 20, 2015, Pardon hampered Mr. Latson's access to treatment options and living facilities, on December 22, 2020, I rescinded the January 20, 2015, Pardon and issued a Conditional and Partial Pardon for **Mr. Latson's** convictions of May 31, 2011, and January 8, 2015, in Stafford County and conviction of March 7, 2014, in Frederick County, and the probation revocations associated with each of those offenses; and


WHEREAS, the conditions of the December 22, 2020, Pardon were to be satisfied on the date Mr. Latson obtained Florida Medicaid but in no event later than three years from the date of the Pardon; and

WHEREAS, it has been represented by legal counsel for **Reginald Cornelius Latson, Jr.**, that as of June 21, 2021, Mr. Latson has received Florida Medicaid.

NOW THEREFORE, in light of the foregoing, in accordance with the provisions of the powers granted to me under Article V, Section 12 of the Constitution of Virginia, I, Ralph S. Northam, rescind the December 22, 2020, Conditional and Partial Pardon granted to **Reginald Cornelius Latson, Jr.** I hereby grant **Reginald Cornelius Latson, Jr.**, a Conditional and Partial Pardon for his convictions of May 31, 2011, and January 8, 2015, in Stafford County and conviction of March 7, 2014, in Frederick County, the probation revocations associated with each of these offenses, and the remainder of his unserved sentence. This Pardon is conditioned solely on Mr. Latson's agreement (1) to release all claims, demands, and causes of action, whether known or unknown, accrued or unaccrued, he has or may have against the Commonwealth of Virginia, as well as its political subdivisions, officials, employees, and agents that are in any way related to or arise out of Mr. Latson's arrest or incarceration in the Virginia Department of Corrections; and (2) that this release is binding on his heirs, assigns, agents, and estate.
